Applications are invited from interested retired OSS Officers of the rank of Section Officers, Desk Officers, Under Secretaries and Deputy Secretaries, not above the age of 62 years and having good service records and physical fitness for appointment as "Officers on Special Duty" on contractual basis in Home (Elections) Department in pursuance of Home Department Resolution No.42595 dt.10.10.2011.

2. The contractual engagement will be made for a period of upto one year or as specified (whichever is earlier) which may be extended by further period of upto one year subject to satisfactory performance and shall not be extended beyond the age of 62 years by the contractual employee. The competent authority reserves the right to terminate the engagement at any time by giving 15 days notice in writing.

3. The retired Officer against whom a vigilance case or Departmental proceeding or criminal prosecution is contemplated or pending or who has been penalised for misconduct during the period upto ten years preceding his / her retirement or is a member of a political party will not be considered for reengagement.

4. Consolidated remuneration of the contractual employee shall be at the rate of his / her last pay + Grade Pay drawn minus the amount of pension sanctioned per month subject to maximum of Rs.10,000/- (Rupees Ten thousand) only per month.

5. The period of contractual engagement shall not be counted as Govt. service for the purpose of pension and any other retirement benefit.

6. The engaged officer will be subject to and will abide by the Conduct Rules applicable to the Government Servants.

7. The appointee will furnish an undertaking at the time of joining the duty in regards to the truth and correctness of the information furnished by him / her.

The interested retired officer fulfilling the above criteria may apply with his / her bio-data, history of service in the Odisha Secretariat with an undertaking that he / she is not a member of any political party and no vigilance case or departmental proceeding or criminal prosecution is contemplated or pending against him / her or

he /she has not been penalised for misconduct during the period upto ten years preceding his / her retirement to the undersigned by 10.02.2012.
